### Effective 2/12/2015:

Final 2015 sub-ACLs have been adjusted for carryover from 2013.

As a result, the sum of the 2015 adjusted sub-ACLs does not equal the stock-wide ACL of 104,566 because the stock-wide ACL cannot be increased by carryover.

#### **Notice**

Quota deductions were made from Herring Areas 1A, 1B, 2, and 3, to account for the 3-percent Herring Research Set-Aside awarded in 2015. These amounts are: 936 mt in Area 1A; 138 mt in Area 1B; 900 mt in Area 2; and 1,260 mt in Area 3.

The Atlantic herring fishery is monitored using data provided by herring-permitted vessels (VMS catch reports and VTRs) and Federal/state dealer data. VMS catch reports will be used to verify and determine catch when VTR and/or dealer records are unavailable, but VTR and dealer reports, once received, will determine final catch by area.

Catch reporting requirements are as follows: Limited access herring vessels report catch daily via VMS, open access herring vessels report catch weekly via the IVR system, and all herring-permitted vessels submit VTRs weekly. Failure to submit reports, including the requirement to submit a negative VTR for any week when no catch was made, has resulted in vessels being referred to the NOAA Office of Law Enforcement for investigation.





2015 Area 1A Quota Report






# Atlantic Herring 2015 Area 1B Quota Report
